

DECREE No. 2020/758 OF 18 DEC 2020
to appoint Senior Divisional Officers

THE PRESIDENT OF THE REPUBLIC,

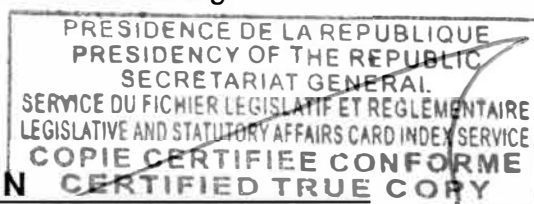

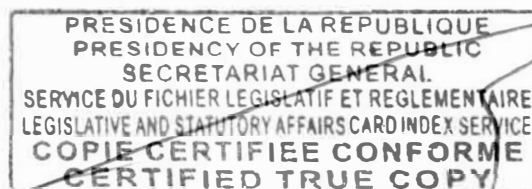
