Mindful of Law No. 2001/005 of 16 April 2001 on the orientation of Higher Education;

Mindful of Decree No. 93/026 of 19 January 1993 to set up universities;

Mindful of Decree No. 93/029 of 19 January 1993 on the administrative and academic organization of the University of Dschang;

Mindful of Decree No. 2011/408 of 9 December 2011 to organize the Government, as amended and supplemented by Decree No. 2018/190 of 2 March 2018;

Mindful of Decree No. 2012/433 of 1 October 2012 to organize the Ministry of Higher Education;

Mindful of Decree No. 2022/003 of 5 January 2022 to set up universities;

Mindful of Decree No. 2022/009 of 6 January 2022 to lay down the administrative and academic organization of the University of Ebolowa;

Mindful of Decree No. 2022/010 of 6 January 2022 to lay down the administrative and academic organization of the University of Garoua,

HEREBY DECREES AS FOLLOWS:

Article 1: The undermentioned persons are, with effect from the date of signature of this decree, appointed to the following positions in some State universities.

SECRETARIAT GENERAL

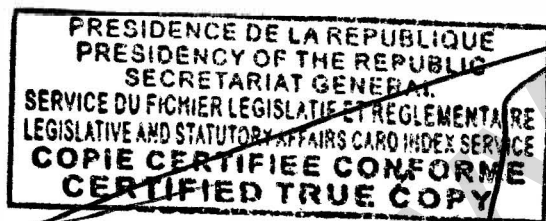
