to order the publication in the Official Gazette of the text of IDA Loan Agreement No. 6770-CM, for an amount of EUR 179.7 million, or approximately CFAF 117.8 billion, concluded on 12 October 2021 between the Republic of Cameroon and the International Development Association (IDA), to finance the Benoue Valley Investment Development and Enhancement Project (VIVA-BENOUE)

**Mindful of Decree No. 2021/556 of 16 September 2021 to authorize the Minister of Economy, Planning and Regional Development to sign with the International Development Association (IDA), a loan agreement for an amount of EUR 179.7 million, or approximately CFAF 117.8 billion, to finance the Benoue Valley Investment Development and Enhancement Project (VIVA-BENOUE),**

**HEREBY DECREES AS FOLLOWS:**
