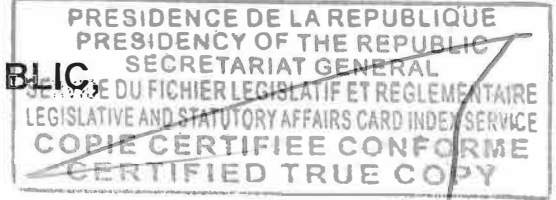


DECREE No. 2024/014 OF 18 JAN 2024
to appoint Senior Divisional Officers

THE PRESIDENT OF THE REPUBLIC,



- Mindful of** the Constitution;
- Mindful of** Decree No. 2008/376 of 12 November 2008 relating to the administrative organization of the Republic of Cameroon;
- Mindful of** Decree No. 2008/377 of 12 November 2008 to lay down the powers and duties of heads of administrative units as well as the organization and functioning of their services;
- Mindful of** Decree No. 2018/190 of 2 March 2018 to amend and supplement some provisions of Decree No. 2011/408 of 9 December 2011 to organize the Government,

HEREBY DECREES AS FOLLOWS:
